

<u>ARTICLE I NAME:</u> The name of the organization shall be Enactus University of Toronto St. George Student Chapter

<u>ARTICLE II MEMBERSHIP</u>: All regularly enrolled students of University of Toronto that are interested in having a positive impact on Toronto, the Country of Canada and the world in general.

<u>ARTICLE III MISSION</u>: The mission of this organization shall be to provide members the best opportunity to make a difference and develop leadership, teamwork and communication skills through learning, practicing and teaching the principles of entrepreneurship.

ARTICLE IV EXECUTIVE STUDENT LEADER: Elected executive leaders of Enactus shall be the President and selected Vice-President roles. Vice President roles include: VP Finance, VP Operations, VP Competitions, VP Ventures, VP Projects, VP Culture and VP Marketing. Elected leaders shall serve for a period of one year, beginning on the first day of the academic year. All voting positions shall be filled through an annual election. Each voting position is open to all student members; all voting members of the Executive Committee must be currently registered students of the University of Toronto. No individual who is seeking election may participate in planning or administering the election. Voting membership is open only to all registered students of the University of Toronto. General members have the ability to appeal decisions made by student leaders, in writing, by contacting the President or any other executive leader.

A, PRESIDENT: Their duties shall be to preside over Enactus meetings and vote in case of a tie, to appoint chairpersons of Enactus committees, and to act as the chief executive of this Enactus organization. In case of vacancy in this office, the Vice-President shall serve as acting President. Enactus will vote for a new President at the next regularly scheduled meeting following the President's resignation.

B. VICE-PRESIDENT: Their duties shall include performing the duties of President when the President is unable to; assist committees in dealing with policies and procedures of the Enactus organization; and, in the case of permanent absence of the President, assume office pending approval of the organization. A vacancy in this office shall be filled by the President, and a new Vice-President will be voted on and appointed at the next regularly scheduled meeting.

<u>ARTICLE V PROJECT COMMITTEES:</u> It is hereby established that the goals and objectives of the Enactus organization shall by carried forward through committees, which will be organized as deemed necessary. The committees shall be separately defined, established, and deleted as necessary.

<u>ARTICLE VI IMPEACHMENT:</u> Any leader may be impeached by a petition of the fifteen percent of the members, or by a 2/3 vote of the voting members present at a regularly scheduled meeting. Definite charges must be brought. A notice of one regularly scheduled meeting must be given to the leader and active voting members. A 3/4 majority of the active voting members present and voting shall be necessary to remove the student from the position.

<u>ARTICLE VII ADVISOR</u>: Advisor(s) shall be the Enactus University of Toronto St. George Student Chapter Faculty Advisor(s).

<u>ARTICLE VIII MEMBERSHIP QUALIFICATIONS:</u> All active voting members must attend at least 50% of the regularly scheduled functions/activities and be active on at least one committee (project). Members



who do not regularly participate in 50% of the functions/activities for a two month period and serve on one committee will be placed on a probationary status.

To be removed from probationary status, the member must attend 75% of the function/activities for a twomonth period and/or become involved in one committee. If the probationary requirements are not fulfilled at the end of the two-month period, the probationary member will be dropped to a non-voting member.

To be reinstated to voting member, the non-voting member must attend 100% of the functions/activities and/or serve on one committee or for a consecutive period of two months

<u>ARTICLE IX FINANCIAL AUDIT</u>: Financial accounts are to be audited by a disinterested party each year, preferable before the accounts are turned over to the newly elected Secretary/Treasurer.

<u>ARTICLE X AMENDMENTS</u>: Proposed amendments to this Constitution must be submitted to the Enactus President in writing. If approved by a 2/3 of the total membership of the organization, a special election shall be held at the next regularly scheduled meeting vote on the proposed amendments. A 3/4 majority vote of those Enactus members voting in the special elections shall be necessary for the acceptance of the amendments.

<u>ARTICLE XI ADOPTION:</u> The Constitution shall be in full force and effective immediately upon passage by a simple majority of the Enactus members voting in the special election.
