## Constitution of International Scientists and Biomedical Research Association

## Article I: Name of Organization

1.1 The official name of the organization will be International Scientists and Biomedical Research Association.
1.2 International Scientists and Biomedical Research Association may be referred to by the acronym ISBRA.

## Article II: Purpose

2.1 The purpose of International Scientists and Biomedical Research Association will be to create an opportunity for passionate undergraduate/young researchers to collaborate with passionate scientists/mentors around the globe.
2.2 International Scientists and Biomedical Research Association will enhance the educational, recreational, social, or cultural environment of the University of Toronto Scarborough by educating students about ongoing research around the globe in their desired field, enhance students' research skills, and provide guidance for their research applications and career.
2.3 International Scientists and Biomedical Research Association fundamentally serves a nonprofit function within the University of Toronto Scarborough, and will not engage in activities that are essentially commercial in nature.
2.4 International Scientists and Biomedical Research Association operates as an independent entity working within the University of Toronto Scarborough community subject to the values and policies of the University.

## Article III: Membership

3.1 Membership in International Scientists and Biomedical Research Association is open to all students, staff, faculty and alumni of the University of Toronto Scarborough and other universities around the globe.
3.2 The term of membership for International Scientists and Biomedical Research Association will be from September 1 - August 31 each year.
3.3 Each member shall be afforded the following rights through membership in International Scientists and Biomedical Research Association:
3.3.1 The right to participate and vote in group elections and meetings;
3.3.2 The right to communicate and to discuss and explore all ideas;
3.3.3 The right to organize/engage in activities/events that are reasonable and lawful;
3.3.4 The right to freedom from discrimination on the basis of sex, race, religion, or sexual orientation;
3.3.5 The right to be free from censorship, control, or interference by the University on the basis of the organization's philosophy, beliefs, interests or opinions unless and until these lead to activities which are illegal or which infringe on the rights and freedoms already mentioned above;
3.3.6 The right to distribute on campus, in a responsible way, published material provided that it is not unlawful;
3.4 Each member shall possess the following responsibilities relative to participation in International Scientists and Biomedical Research Association:
3.4.1 Support the purpose of the organization;
3.4.2 Uphold the values of the organization;
3.4.3 Contribute constructively to the programs and activities offered by the organization;
3.4.4 Attend general meetings;
3.4.5 Abide by the constitution and subsequent official organizational documents;
3.4.6 Respect the rights of peers and fellow members;
3.4.7 Abide by University of Toronto policies, procedures, and guidelines;
3.4.8 Abide by the Laws of the Land, including but not limited to the Criminal Code of Canada.
3.5 International Scientists and Biomedical Research Association will collect a mandatory membership fee from each member each year when necessary. This fee will be proposed as part of the operating budget presented to general members for approval at a valid general meeting.
3.6 International Scientists and Biomedical Research Association values and respects the personal information of its members. International Scientists and Biomedical Research Association secures its member's information at all times and will not supply names or other confidential information to third-parties.
3.7 International Scientists and Biomedical Research Association will protect the privacy of member information and must use it only for the delivery of service and not for commercial gain.
3.8 The process for becoming is member of International Scientists and Biomedical Research Association is as follows: new member has to contact the Director of Academics (academics related) or Director of Human Resources (non-academics related) along with their CV, interest, and other necessities as applicable. A meeting with Vice President of the association would be held if necessary. The incoming member must sign a form with the rules and regulation to be a member of the association.

Article IV: Executive
4.1 The executives of the organization shall include President, Vice President, and Directors of Human Resources, Finance, Academics, External Affairs, and Production.
4.2 The broad responsibilities of each executive position are as follows:
4.2.1 President is the official spokesperson of the organization and provides direction for all components of the organization in a manner consistent with the organization's constitution and policies. Also, recruits new executive and general members as well as guide throughout projects.
4.2.2 Vice President works under the the supervision of the President to aid in running the association, maintain a record of enrolled members and their activity, collaborate with Directors to ensure that association is running efficiently, as well as aid in interviewing new applicants.
4.2.3 Director of Human Resources work under the supervision of the President to regulate non-academic work of the association including recruitment of new non-academic applicants, prepare and arrange association meeting schedules.
4.2.4 Director of Finance work under the supervision of the President to regulate the finance of the association. This includes finding funding opportunities available for association to apply, completion of those applications along with the help of association members, keep a record of the expenses and funds received for the association.
4.2.5 Director of Academics work under the supervision of the President and acts as an advocate and resource for the academic issues and support of members, ensuring accessible, high quality education.
4.2.6 Director of External Affairs develops timely outreach assets alongside Director of Production (e.g. videos, infographics, ads, data visualizations, photos, animations, presentations, testimonials, flyers, web pages, social media posts) that are effective at demonstrating the value of programs to the target participants.
4.2.7 Director of Production supports the creation and optimization of the content for social media platforms and other digital platforms; and executes original content concepts.
4.3 Only student members of the organization may hold executive positions.
4.4 The executive positions collectively will form a committee that acts as the primary steward of the organization.
4.5 This committee is collectively responsible for the day-to-day decision making of the organization including but not limited to monitoring finances, event planning and execution, member services, and advocating on behalf of members to Administration and student government.
4.6 This committee cannot make amendments to the constitution without the approval of the President at a valid general meeting.
4.7 The term of each executive will be based on the discretion of President by taking their efforts and contribution consistency/length (if applicable) in consideration.
4.8 Any executive of the organization may resign, provided that such resignation is made in writing and delivered to the President, two months prior to resignation. Unless any such resignation is, by its terms, effective on a later date, it shall be effective on delivery to the President, and no ratification by the organization shall be required to make the resignation official.
4.9 Any vacancy of executives shall be filled by the President or designate of the organization until such a time where a permanent appointment occurs, or a hiring process is conducted.
4.10 If the President resigns, notice of such resignation must be submitted in writing and delivered to the executive committee at a valid executive meeting. Unless any such resignation is, by its terms, effective on a later date, it shall be effective on delivery to the executive committee, and no ratification by the organization shall be required to make the resignation official.
4.11 Any vacancy of the President shall be filled by another executive committee member appointed by a simple and clear majority of the executive committee until such a time where a permanent appointment occurs, or a hiring process is conducted.

## Article V: Removal of Members and Executives

5.1 The process for removing a member or executive may be initiated when a committee of 1) President, or 2) no less than three (3) non-executive general members, President, and one (1) other executive member appointed investigate a complaint determines that:
5.1.1 A member or executive has engaged in unlawful actions or activities;
5.1.2 A member or executive has violated the constitution;
5.1.3 A member or executive has violated University of Toronto policies, procedures, or guidelines;
5.1.4 A member or executive has violated the rights of a fellow member;
5.1.5 A member or executive has not fulfilled their organizational responsibilities;
5.1.6 Other criteria deemed to be appropriate by the Executive Committee in consultation with and approved by a majority of the general membership.
5.2 The process for removing a member or executive may also be initiated when:
5.2.1 A petition calling for a vote and bearing the signatures of a majority of the general membership is submitted to President.
5.2.2 A motion for a removal vote is put forward by President and passed by a two-thirds majority vote of the executives. The individual facing potential removal vote is entitled to vote on the motion if they are an executive or be given an opportunity to explain themselves if they are a non-executive general member.
5.3 The removal of members and executives will be facilitated by a three tier procedure which operates as follows:
5.3.1 First Tier:

- The executive or member will be warned both verbally and in writing that their behavior constitutes grounds for removal from the organization and that it should cease effective immediately.
5.3.2 Second Tier:
- Initiated because the member or executive has violated section 5.1 after receiving a first tier warning relative to a particular action or behavior.
- The President will be responsible for contacting the executive or member and facilitating training or suggesting best practices on how to correct the issues of concern.
- The President must address all complaints in writing by formulating an action plan and timeline to correct any issues involving executives or members within fourteen (14) calendar days.
- The executive or member accused of violating section 5.1 will be given fourteen (14) calendar days from receiving the President's written response to demonstrate progress or correction of behavior.
5.3.3 Third tier:
- Initiated because the member or executive has violated section 5.1 after receiving second tier warning relative to a particular action or behavior.
- The removal vote must take place at a valid general meeting of the membership. A representative supporting the motion for removal and the executive or member facing removal (or an individual they designate), may speak for up to five minutes each.
- The removal of an executive or member requires approval of President upon an unbiased investigation into the case.


## Article VI: Finances

6.1 The funds of the organization shall be expended pursuant to the operating budget approved by the President at a valid general meeting.
6.2 Notwithstanding section 6.1, the executive committee may not approve any unbudgeted expenditure of the organization's funds above $\$ 100.00$ without the approval of the President at a valid general meeting.
6.3 All Budgets shall be prepared by the Director of Finance in accordance with the organization's priorities as determined by the President in consultation with executive members at a valid general meeting.
6.4 The Director of Finance shall present a proposed operating budget for the next fiscal year to the general membership for its consideration at the final general meeting.
6.5 The operating budget shall be the major budget for the fiscal year and provide for all expenditures of the organization for the subsequent year.
6.6 The operating budget shall be approved by President presented at a valid general meeting.
6.7 The banking business of the organization, or any part thereof, shall be transacted with such bank, trust company or other firm or body corporate as the President may designate, appoint or authorize from time to time and all such banking business, or any part thereof, shall be transacted on the organization's behalf by the President, direct or authorize from time to time and to the extent thereby provided.
6.8 The President, and only in special circumstances the Vice President, shall be the sole signing authorities of banking instruments for the organization.
6.9 International Scientists and Biomedical Research Association will ensure that proper and accurate financial records are maintained and passed on to incoming executives following each year's elections.
6.10 International Scientists and Biomedical Research Association will accept full financial and production responsibility for all activities it sponsors, plans, or executes.

## Article VII: General Meetings

7.1 The purpose of General Meetings is to provide a forum for executives to overview the activities of the organization and solicit feedback from members, to engage in policymaking, to propose amendments to the constitution, and to report on the financial status of the organization.
7.2 General meetings will be facilitated by a President. The President shall be responsible for:
7.2.1 Formulating and distributing an agenda for each meeting no later than two (2) days before the meeting;
7.2.2 Ensuring appropriate conduct and leading the meeting in an efficient, reasonable manner;
7.2.3 Moderating the discussion at meetings according to the agenda;
7.2.4 Suspending members from participating in meetings for constitutional or procedural violations.
7.3 The procedure at meetings of members shall be governed in accordance with the process outlined in Appendix A.
7.4 There shall be a minimum of one (1) general meeting held each month. The date of each subsequent general meeting will be confirmed at the preceding general meeting and will be reiterated to members via email a minimum of two (2) calendar days prior to the meeting.
7.5 General meetings may be called to order by the President, through a petition by a petition signed by three (3) executive members, or by a petition signed by five (5) nonexecutive general members.
7.6 General meetings are open to registered members of the organization only. Quorum will first be established by the presence of a simple and clear majority of the executives.
7.7 For quorum to remain valid, the number of non-executive general members present at a general meeting must exceed the number of executives present at all times.
7.8 All executives are expected to make brief progress reports on their activities at every general meeting.
7.9 Minutes of all general meetings must be recorded and maintained for reference purposes.
7.10 Members must contact the President a minimum of 48 hours before a general meeting to inform them of new business they wish to discuss. The President will then add the discussion item to the agenda.
7.11 Each member of the organization shall be entitled to one (1) vote at a general meeting except the President who shall only vote in the event of a tie.
7.12 Any question at a valid general meeting shall be decided by a show of hands.
7.13 Whenever a vote by show of hands occurs, a declaration by the President that the vote upon the question has been carried, carried by a particular majority, or failed shall be recorded in the minutes of the meeting.
7.14 In case of an equality of votes at a valid general meeting, the President of the meeting shall have the deciding vote.
7.15 The President presiding over a meeting of members may, with the consent of the majority of members, decide to adjourn these meetings from time to time.

## Article VIII: Executive Meetings

8.1 The purpose of executive meetings is to provide a forum for the organization's executives to discuss and make decisions on day-to-day matters affecting the organization.
8.2 Executive meetings will be facilitated by the President of the organization. The President shall be responsible for:
8.2.1 Formulating and distributing an agenda for each meeting;
8.2.2 Ensuring appropriate conduct and leading the meeting in an efficient, reasonable manner;
8.2.3 Moderating the discussion at meetings according to the agenda;
8.3 There shall be a minimum of one (1) executive meeting held every two (2) weeks during the period September 1 to April 30. The date of each subsequent executive meeting will be confirmed at the preceding meeting and will be reiterated to executives via email a minimum of two (2) calendar days prior to the meeting.
8.4 The frequency of executive meetings occurring between May 1 and August 31 will be left to the discretion of the President.
8.5 Executive meetings may be called to order by the President or through a petition signed by three (3) executive members.
8.6 Executive meetings are restricted to executive members only. Quorum will be established by the presence of a simple and clear majority of the total executives for the organization.
8.7 Minutes of all executive meetings must be recorded and maintained for reference purposes.
8.8 Executives must notify the President a minimum of six (6) hours before an executive meeting to inform them of new business they wish to discuss. The President will then add the discussion item to the agenda.
8.9 Each executive member of the organization shall be entitled to one (1) vote at a valid executive meeting.
8.10 Any question at an Executive Meeting shall be decided by a show of hands.
8.11 Whenever a vote by show of hands occurs, a declaration by the President that the vote has been carried, carried by a particular majority, or failed shall be recorded in the minutes of the meeting.
8.12 In case of an equality of votes at an Executive Meeting, the motion will be recorded as having failed.
8.13 The President may, with the consent of the majority of executives, decide to adjourn these meetings from time to time.

## Article IX: Emergency Meetings

9.1 Emergency meetings can be called for extenuating or unforeseen circumstances that may arise from time to time.
9.2 These meetings must abide the respective rules outlined in sections VII and VIII depending on the nature of the meeting.
9.3 Notice of these meetings must be provided a minimum of 24 hours in advance through email.
9.4 Less notice for emergency meetings may be provided at the discretion of the President in agreement with a minimum of five (5) general members.

## Article X: Amendments

10.1 The organization may make, amend or repeal the constitution or certain sections therein.
10.2 Notice of a meeting called to consider such a resolution shall be given as follows:
10.2.1 Notice of the full text of the proposed constitutional amendment shall be given to each member at least fourteen (14) days prior to the date of the meeting called to consider the change;
10.2.2 A summary of the rationale for the proposed amendment shall be given to each member at least fourteen (14) days prior to the date of the meeting called to consider the change.
10.3 Amendments to the constitution require the approval of President at a valid general meeting.
10.4 The President must have the final say on amendments to the constitution.

## Article XI: Transition

11.1 All outgoing executives are required to transfer all organizational resources used relative to a particular role over the course of the preceding year to new executives upon leaving the position.
11.2 All outgoing executives are responsible for providing a detailed report to incoming executives that stipulates the status of ongoing projects in their portfolio and evaluations of previous projects and programs that they lead.
11.3 All outgoing and incoming executives will participate in a joint training session occurring no later than the end of May each year to assist with the transition between new executive teams.

## Article XII: Emergency Powers

12.1 In the case of extenuating circumstances, the President shall be afforded the ability to act without direction from the organization's members.
12.2 An extenuating circumstance is defined as any instance that may jeopardize the immediate functioning of the organization including but not limited to: executive vacancies, unexpected cancellations, removal from position, or lack of response from members.
12.3 Emergency powers may only be used for such a period of time as is needed to address an extenuating circumstance.
12.4 President have the ability to remove emergency powers where appropriate.

Article XIII: Food Handling on Campus
13.1 International Scientists and Biomedical Research Association will conform to Provincial and Municipal Health Regulations when events which include the sale and/or service of food products are held on the University of Toronto Scarborough campus.

## Article XIV: Precedence of University Policies

14.1 International Scientists and Biomedical Research Association will abide by all pertinent University of Toronto policies, procedures, and guidelines. Where the University's policies, procedures, and guidelines conflict with those of International Scientists and Biomedical Research Association, the University's policies, procedures, and guidelines will take precedent.

## Article XV: Legal Liability

15.1 The University of Toronto Scarborough does not endorse International Scientists and Biomedical Research Association's beliefs or philosophy nor does it assume legal liability for the group's activities on or off campus.

## Article XVI: Banking

16.1 International Scientists and Biomedical Research Association agrees to provide the name of the bank, the branch number and address, transit number, bank account number, and a list of all signing officers for all bank accounts opened in the organization's name to the Office of Student Experience and Wellbeing at University of Toronto Scarborough, should the university request it

## Appendix A: General Meeting Rules of Order

## I. Call to Order

1. The President may call the meeting to order only if a quorum of executives and non-executive general members is present in person. If a quorum does not exist, the meeting is not qualified to conduct business. A general member may not appear by proxy or mail ballot.
2. The meeting must be open to all applicable general members. General members must receive notice of the meeting in accordance with, the constitution.

## II. Review of the Agenda

1. The first draft of the agenda is prepared by the President prior to the meeting. Agenda items should ordinarily appear in the order set forth in these rules of order.
2. The agenda belongs to all general members. The agenda may be modified only by President. This power should only be used when necessary as proper functioning of meetings and the organization requires advance planning.
3. At this point in the agenda, President may add or delete items from the agenda and may change the order of presentation.
4. When possible, changes to the agenda should be done by acquiescence of President. Formal voting on the agenda is only necessary where it appears to the President that there is a necessity.

## III. Approval of Previous Minutes

1. The minutes need not be read aloud but they should be entered into the organization's official minute ledger upon approval by the President.
2. The minutes are prepared by President. Any general member may suggest changes to the minutes before the President adopts them. The suggested changes should be set forth in the minutes for the record, and then the President should adopt or reject such changes.
3. Minutes should state precisely each motion considered by the President, and identify the general members suggestions in favor, against, or abstaining, and whether the motion was carried. Minutes need not reflect the comments made except in those instances when the member desires to make his/her comments recorded.
4. When possible, changes to the minutes and adoption of the minutes should be done by acquiescence of President. Formal voting on the minutes is only necessary where it appears to the President that there is a necessity.

## IV. Executive Reports

1. Executives may report their findings or recommendations to the President at this point of the agenda.
2. The full report should be presented and then general members, in turn, may ask questions or comment. It is not appropriate to make motions or discuss items of business during this portion of the meeting.
3. This time should also be used for any presentations to be made to the general membership.

## V. Open Forum

1. It is the custom and practice of most organizations to allow general members an open forum to ask questions and speak about their concerns to an executive after a report has been provided.
2. Strict time limitations should be imposed by the President and these limitations must be enforced. Each general member should address the President regarding an issue and must speak courteously and to the point.

## VI. Old and New Business

1. All items that were tabled during previous meetings must be revisited during the business portion of the agenda occurring after executive reports.
2. The President may vote to postpone consideration of any old business or it may remove any item from consideration.
3. Except in the case of emergency business, all new items of business are heard only after all of the old items have been addressed by the President.
4. All business must be conducted in the form of motions or resolutions adopted by the President.

## VII. Motions and Deliberations

1. When an item of business is to be discussed, the President announces the item to be discussed and opens the floor to discussion.
2. No general member may speak until recognized by the President. No general member may interrupt the speaker who has the floor.
3. The President may impose reasonable time limitations. All time limitations must be uniformly imposed upon all of the general members. The speaker shall be given a one-minute warning before time runs out. By vote of a majority of the general membership, time limits may be extended.
4. The President is to recognize each general member in turn. Discussion shall be limited to the item of business at hand, and the President shall have the authority to take the floor from a speaker who does not limit discussion to the item of business at hand.
5. No general member may speak to an issue for a second time until all other general members have had the opportunity to speak to it for the first time. Likewise, no general member may speak to an issue for a third time until all other general members have had the opportunity to speak to it for a second time.
6. When it appears to the President that all general members have had the opportunity to fully discuss the matter at hand, the President should announce that the item of business is ready for a vote.
