# Constitution of University of Toronto Korean Engineering Students' Association (UTKESA)

## I. NAME

University of Toronto Korean Engineering Students' Association (UTKESA)

## **II. PURPOSE**

- 1. To bring together the University of Toronto students through discussions, sports and diverse cultural and social activities.
- 2. To promote Korean-Canadian students in becoming adults members of the Korean-Canadian community, and citizens of Canada.
- 3. To share the knowledge of Korean culture and tradition with students of non-Korean origin in the Canadian society.

# III. MEMBERSHIP

- 1. The members are composed of regular and honorary members.
- 2. A regular member is defined as a person who is a registered student from the University of Toronto and has paid the required membership fee of \$25 for the designated year.
- 3. An honorary member is defined as a person who has graduated from the University of Toronto and was previously a regular member while he/she was a student.
- 4. All regular members have full voting rights in the election of the president and executives.
- 5. All regular members are able to apply for executive positions for the next year.
- 6. All members are able to propose new events or constitutional amendments at the annual brainstorming meeting held after the election of the president.

## IV. FINANCES

- 1. The basic financial procedure of UTKESA includes
  - a. a) fees received from members for each event attending,
  - b. b) donations made by alumni members and
  - c. c) funding from other organizations (i.e. EngSoc, AKCSE, KSAC, etc.)
- 2. The membership fee of \$25 includes a Club T-shirt, participation fees for the General Meeting.
- 3. Refer to section VII. EXECUTIVE for the roles of the Executive Finance & Planning Director and the Treasurer.

# **V. MEETINGS**

- 1. An annual general meeting shall be called upon by the president of UTKESA at the beginning of the first term each year.
- 2. A temporary meeting shall be called upon by the president whenever he/she acknowledges its necessity or upon the request of more than 15 regular members in writing to the president.
- 3. The general meeting shall be held in the presence of at least one third of the regular members.

### VI. ELECTION

- 1. The election of all positions shall be held annually towards the end of the second term for the following year before the final exams.
- 2. Voting membership is open only to registered students (regular members) of the University of Toronto.
- 3. The president shall be elected by secret ballot in the election in which at least a half of the number of regular members is present.
- 4. The executives shall be elected by secret ballot in the election in which at least a half of the number of regular members is present. All voting members of the Executive Committee must be currently registered students of the University of Toronto.
- 5. All voting positions on the Executive Committee shall be filled through an annual election and each voting position must be open to all student members.
- 6. The elections must be held in a nonbiased manner. No individual who is seeking election may participate in planning or administering the election.
- 7. The presidency of the new president shall be effective from the 1st day of May each year.
- 8. The candidates for the UTKESA president election must be running mates: one team with two candidates of a president and a vice-president.
- 9. The candidate for UTKESA president is open to all student members.
- 10. If the president resigns during his/her presidency, the current vice-president shall be promoted as the president and new vice-president will be elected by secret ballot in the election in which at least a half of the number of regular members is present.

#### VII. EXECUTIVE

The committee consists of the following executive members and each member shall serve for the duration of one academic year.

#### Co-President

- shall represent the Korean Engineering Student Association
- shall be in charge of all the activities and events held on behalf of the UTKESA
- shall preside at all committee meetings
- hold signing and financial authority along with the Treasurer

#### **Executive Finance Director**

- shall be responsible of the UTKESA bank account
- shall be in charge of planning and creating a budget for all the events
- hold signing and financial authority along with the Treasurer

# **Executive Marketing Director**

- shall be responsible for advertising and marketing UTKESA events

#### **Executive Events Director**

- shall be responsible for organizing and planning UTKESA events

#### **Executive Academics Director**

- shall be in charge of all academic activities such as seminars

# **VIII. IMPEACHMENT OR TERMINATION OF MEMBERSHIP**

- 1. Any executive, regular, or honorary member may be impeached and/or have their membership terminated.
- 2. All members may raise impeachment but there must be a legitimate reason which at least half of the executives agree upon.
- 3. Once approved by the executive members there will be a group meeting held where at least half the number of regular members must be present. Here the accuser and accused member will be given an equal opportunity to defend him/herself. There will be a vote at the end whether or not to terminate the membership of the accused.

## IX. AMENDMENTS AND ADDITIONAL RULES

- 1. Any amendment to the constitution shall be made by at least one half votes of the regular members present at the general and brainstorming meetings.
- 2. The constitution shall take effect on the first day of the first term each year.
